




Please indicate whether you think each environmental service is of low, medium, or high importance to you and/or your business:



Text Response

When trying to please all stakeholders, you end up trying to accommodate even those who are damaging the environment. I would not use mussel landings as a criterion unless they are harvested sustainably. I would not want any more cruise ship visits. We can smell their exhaust and hear their engines all they way at the other end of the bay.

Since 1978, I've seen a major decline in the sea duck population. Having once seen rafts of Black Ducks in the hundreds, to now seeing more than a dozen at a time is unusual. The mussel beds have been dragged up and the eel grass with them. And for whatever reason, the clams have declined.

A more careful set of questions would have been of more use. Should consider "alpha" and "beta" testing next time.

I have a degree in Integrated Coastal Science, Policy and Management.

Your survey seems to be focused on justifying your programs to the larger community. I believe it is a sad reality that people value their near term income over the long term health of their local environmental world. If the only way we can gain support for programs such as yours is by measuring effectiveness in economic terms, then we must do so. But it leaves out the universal law of the Commons: the air, the water, the ecology, the plants, the animals belong to everyone. That you or I can harvest our fair share of these gifts we assume to be a safe baseline for a healthy world. But for me to scale up my takings to a level that far exceeds my share clearly will lead to an unsustainable future.

I believe we as a society need to evaluate the concept of scale in all of our activities as we seek new approaches to management of our resources.
